





Sub. : Engagements of retired Superintendents of Police/ Additional Superintendents of Police from CBI on contract basis in Special Vigilance Unit, Patna.

Sir,

As you are aware that Government of Bihar has, vide Memorandum No. 3538 dated 12.07.2013, sanctioned the posts SP/Addl. SP rank in SVU, Bihar for conducting investigation into cases of possession of Disproportionate Assets & Trap against the public servants. The officers of the Superintendent of Police/ Additional Superintendent of Police rank would be taken on contract basis initially for 3 years. The contract can thereafter, be renewed annually to attaining the age of 68 years.

2. Terms of engagement of retired SsP from CBI are as under:-

- (i). Monthly contract amount of Rs. 70,000/-
- (ii). Compensation towards expenses on office/residence Rs. 12,000/-P.M.
- (iii). Payment toward Mobile phone Rs. 1000/- P.M.

3. I would request you kindly to intimate the names, addresses and contact details of the Superintendents of Police and Additional Superintendents of Police who have retired in last 2/3 years from CBI. Besides, it is also requested that wide publicity may be given within the CBI about the engagements of retired Superintendents of Police from CBI by Government of Bihar.
