Auction will be held separately for each vehicle. The terms and conditions of the sale are as under :-

- (i) The vehicle will be sold on "as is where is basis"
- (ii) Before commencement of the auction, every intending bidder will have to deposit a sum of Rs. 5000/- for car and Rs. 1000/- for motor cycle in cash as earnest money which will be refunded to the unsuccessful bidders after the auction proceedings are over.
