
Sub:- DISPOSAL OF CONDEMNED GOVERNMENT VEHICLE.

- 2 The quotation should be in sealed cover super scribed "Quotation for A Ambassador. Car bearing No. DLCQ-5900 and addressed to the Supdt. of Police (A),CBI, AC-III, Plot No.5-B, CGO,Complex, Lodhi Road, New Delhi-110003 alongwith cash of Rs.5000/- as earnest money which will be received in this office latest by 1500 hrs. on 29.03.2016 and shall be opened at 1600hrs. on the same day. The quotation shall not be accepted unless accompanied by the earnest money of Rs.5000/- in cash.
- 3 The terms and conditions are as under:-
  - (i) The vehicle will be disposed on "as is where is basis"
  - (ii) Every quotationer will have to deposit a sum of Rs. 5000/- in cash as earnest money which will be refunded to the unsuccessful quotationer after the proceedings are over.
  - (iii) The successful quotationer will have to pay 25% of the quoted amount in cash immediately on the spot failing which the deposit amount of Rs. 5000/- will be forfeited. The balance 75% amount will have to be paid within next 2 working days failing which the amount of 25% as deposited by successful quotationer will be forfeited. The vehicle will have to be removed immediately after making full payment by the successful quotationer at his own cost.
  - (iv) The successful quotationer (s) should furnish identity and Residential Address proofs and details of PAN issued by Income Tax authorities.
  - (v) The CBI/AC-III Branch reserves the right to accept/reject offer quotation without assigning any reason whatsoever.
