2 Auction will be held separately for each vehicle. Terms and conditions of the sale are as under:-

- i. The vehicles will be sold on "as is where is basis".
- ii. Before commencement of the auction, every intending bidder will have to deposit a sum of Rs.2,000/- per vehicle in case as earnest money which will be refunded to the unsuccessful bidder after the auction proceedings are over.
- iii. Successful bidders will have to pay 25% of the bid amount in cash immediately on the spot failing which the deposited amount as earnest money @ Rs.2,000/-, will be forfeited. The balance 75% amount will have to be paid within next 2 working days of the auction failing which the bid amount of 25% amount as deposited by successful bidder will forfeited. The vehicle(s) will have to be removed immediately after making full payment by the successful bidder at his own cost.

- v. The CBI, ACB, Gandhinagar reserves the right to accept/ reject any offer / bid without assigning any reason whatsoever.
