

**AUCTION NOTICE**

It is hereby notified for the information of the General Public that the CBI/STF/New Delhi has some condemned/unserviceable electronic items/goods **Viz.** HP Scanner Jet, Printer HP Laserjet, Printer Samsung Laserjet, Printer HP Deskjet and Philips Colour T.V which are scheduled to be sold by the public auction on **19/12/2017** at 14:00 hours. The auction will be held in the premises of this office at CBI/STF, 5-B, 5<sup>th</sup> Floor, CGO Complex, Lodhi Road, New Delhi-110003.
