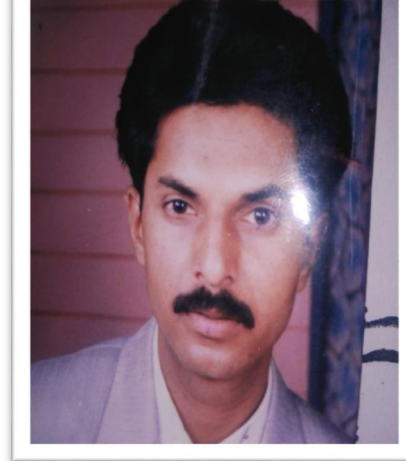

**Brief History of the Case:-**

Accused persons Shri A.B. Solanki, the then Branch Manager, Bank of India, BHEL, Bhopal, S.B. Gokha, then Clerk, Bank of India, T.T. Nagar, Bhopal and S.K. Sharma, Proprietor of Sharma Photostate and Typing Centre, , 12, CPA Building, Arera Colony, Bhopal entered into a criminal conspiracy to cheat the Bank of India, BHEL during the year 1988-89. In furtherance of the said conspiracy Shri A.B. Solanki disbursed a term loan for purchase of photocopier in the name of |Shri Ghanshyam Bangde on the basis of signatures of Shri Ghanshyam Bangde forged by Shri S.B. Gokhe and false agreement for sale of 'Cano N P-271 Photocopier. Thus by the aforesaid acts Shri Sunil Kumar Sharma and Shri Ghanshyam Bangde in pursuance of criminal conspiracy caused wrongful loss to the tune of Rs. 66,000/- to the Bank of India, BHEL, Bhopal and corresponding wrongful gain to themselves. Shri Ghanshyam Bangde is absconding since Feb' 1998, and declared absconder on 06/07/2001. A Standing NBW of arrest has also been issued by the Hon'ble Special Magistrate, Indore. He was declared PO on 28/02/2004.
