It was alleged that Raj Kumar Churewal , Rajesh Churewal, Surendra Kumar Churewal, Madhav Churewal all Directors of M/s SRM Bolt Manufacturing Pvt. Ltd., entered into criminal conspiracy with Shri Sankar Bijoy Saha, Sub Manager,UBI, Old Court Steet, Kolkata and availed a credit facilities upto the tune of Rs. 317 lacs on the basis of fake documents and did not repat the same causing thereby a wrongful loss to UBI and corresponding wrongful gain to them to the tune of Rs. 28777372/- Chargesheet was file in LD Court of 14<sup>th</sup> Metropolitan Magistrate, Kolkata against Sh Raj Kumar Churewal , Rajesh Churewal, Surendra Kumar Churewal, Madhav Churewal.

**CBI, EOW, Kolkata Case No. RC 7/E/2004**

Case was registered on 29.11.2004 U/s 120B, 467,468 &471 IPC , complaint of UCO Bank. It was alleged that Sh Raj Kumar Churewal, Prop of Hindustan Engineering Works entered

into criminal conspiracy with other unknown person and availed open cash credit facilities from Canara Bank, 2 Brabourne Road Branch to the tune of Rs. 1.30 Crores by submitting forged & fabricated documents. After availing the loan facility it was utilized for the purpose other than for which it was sanctioned causing a wrongful loss to Canara Bank and corresponding wrongful gain to themselves.
