8. Facts of the Case: Case RC.7(S)/1996 was registered in CBI, SC-II, New Delhi on 29.10.1996 on the orders dated 17.10.1996 of the Hon'ble High Court of Punjab & Haryana at Chandigarh. Accordingly, investigation of FIR No. 111/96 dated 22.04.1996 u/s 302/34 IPC of PS Samalakha, Panipat, Haryana with respect to the murder of deceased Sushil Kumar Jain was entrusted to CBI.

The allegation in brief is that accused PO Hira Lal @ Babli, s/o Surja, r/o Village Khairpur, PS Pilkhuwa, District Ghaziabad, Uttar Pradesh conspired with other co-accused and killed Sh. Sushil Kumar Jain. On completion of investigation, Chargesheet was filed in the Court

of Ld. Special Judge, Ambala on 17.02.1997 against the accused u/s 120-B r/w 302 IPC and section 302 r/w 34 of IPC and 25/27 Arms Act.

Accused Hira Lal @ Babli absconded from the custody of Police on 06.06.1998, during the course of trial of this case. He was declared Proclaimed Offender (PO) by the Court of Law on 12.12.1998. A Look Out Circular (LOC) No. 1842285 with validity till 15.04.2019, has been issued against the accused.
