RC-13/2005	17.06.2011	<p>The charge sheet in this case was filed on 14.12.2007 in the court of Ld. Special Judge CBI Cases, Jodhpur. As the accused Sh. K.L. Lakhotia did not appear before Ld. Court, arrest warrant was got issued against him but the same could not be got executed in spite of best efforts. Thereafter accused Sh. Kanwar Lal Lakhotia was declared absconder by the court on 17.06.2011.</p> <p>To present whereabouts of absconder Kanwar Lal Lakhotia, Shri Rohitash Yadav, PC, & M.K.Sharma, ASI, CBI, Jodhpur were deputed in this regard. They visited Surat (Gujrat) and contacted brothers and brother in laws of absconder but no fruitful clues could be recovered/gathered. They also visited Gadodara, Surat, where the relatives of Kanwar Lal Lakhotia are residing, for enquiring about whereabouts of Kanwar Lal Lakhotia. All of them confirmed that they have not in contact with and has not seen for the last 10-12 years. Subsequently, Shri M.K.Sharma, ASI & Rohitash, PC also visited at the residential address of relatives of Kanwar Lal Lakhotia situated at Flat No. 329, Sai Nath Apartment, Tikam Nagar Surat, they informed that Kanwar Lal Lakhotia has not been seen for last 10-12 years.</p> <p>Thereafter, Shri M.K.Sharma, ASI & Rohitash Yadav, PC, CBI, Jodhpur also visited at his brother-in-laws house situated at flat No. 204, Maha Lakshmi Apartment, Radha Krishan Timber Road, Tikam Nagar, Surat and brother's house of Kanwar Lal Lakhotia situated at flat No. 802, Shiv Shakti Complex, Hari Nagar, Laksmi Narayan, in front of temple, BRC Road, on enquiring present whereabouts of Kanwar Lal Lakhotia but no clue could be gathered. Shri Lal Chand Lakhotia (brother of kanwar Lal Lakhotia) and his wife Smt. Sweta Lakhotia informed that Kanwar Lal Lakhotia might be in regular touch with their in-laws..</p> <p>Continuous efforts are being made to whereabouts of absconder Kanwar Lal Lakhotia and catch him.</p>
