8. Facts of Case: This case relates to commission of Dacoity and Looting by the terrorists of Khalistan Commando Force on 12.02.1987 from Punjab National Bank, Ludhiana. An FIR No. 26/87 was registered at PS Div. No. 6, Ludhiana, Punjab with respect to the above said crime. Later on, the investigation of this case was entrusted to the CBI by the Ministry of Personnel, Public Grievances and Pension, Deptt. of Personnel and Training, Govt. of India and accordingly, Case RC.1(S)/1987 was registered in CBI.

The allegation in brief is that PO Mahishinder Singh @ Maheshi, S/o Gurcharan Singh, R/O Village Gehal, PS Bhawanigarh, Sangrur, Punjab; conspired with other co-accused persons and facilitated the dacoity in the aforesaid bank.

After completion of investigation, a Chargesheet dated 14.07.1988 and two Supplementary Chargesheets dated 22.10.1991 and 24.09.1996 respectively were filed before the competent Court against the accused persons. PO Mahishinder Singh @ Maheshi is absconding since beginning. He was shown in Col. No. 2 of the Chargesheet. He never joined the investigation of this case.

The accused has been declared Proclaimed Offender (PO) by the Court of Law vide order its dated 03.11.1988. A Look Out Circular (LOC) No. 1840658 with validity till 01.02.2019, has been issued against the accused.
