

Content of the FIR is as follows:

Sir,


I am Mamoni Khetrapal, age- 24 years, w/o- Palas Khetrapal, r/o- Village- Nabagram, Post- Nabagram, PS. Jamalpur, Distt. Purba Bardhaman.

It is being informed that today i.e. on 03.05.2021, at around 2.10 pm, afternoon, some Trinamool Congress supporters came to my neighbor's house looking for Anil Khetrapal and his son. At that moment, finding no sign of Anil Khetrapal and his son, said Trinamool Congress supporter started vandalizing his (Anil Khetrapal) house. On seeing this, Kakuli Khetrapal, W/o Anil Khetrapal tried to obstruct them. During such obstruction, said Trinamool Congress supporters struck her with the sharp weapon that they carried with them. As a result, Kakuli Khetrapal was severely injured and drenched in blood. When Kakuli Khetrapal was taken to Jamalpur hospital for treatment, the doctor declared her dead. After this incident, when Anil Khetrapal and his brother returned to the spot, they too were grievously injured.

I do not know the names of all persons who were involved in this incident, though I can identify if I see them. However, names and addresses of such persons who are known to me are given below.
